PURPOSE: The purpose of the course is to familiarize the student with the American legal system and how it affects the free enterprise system.

OBJECTIVE: In a business situation, when a legal issue arises, the student should be able to identify the problem and determine what action, if any, is necessary.

PROCEDURE: Class discussion of the assigned chapters and the presentations.

ATTENDANCE: Because successful completion of this course depends largely upon regular class attendance, excessive absences, even if necessary, may deprive the student of a grade that reflects their capabilities, and may even result in failure of the course.

PRESENTATION: Each student will participate in a group of three students to present a topic of the groups choosing to the class. Groups will be formed and topics selected by Session 2 with all presentations completed by the end of Session 7 with no more than two presentations per Session.
