# Immigrant: Moving to a new country to live there permanently

# **Emigrant:** Person who leaves his/her country to live in another

# INS (Immigration and Naturalization Service): The government bureau that administers the U.S. immigrant policy

Illegal VS. Undocumented Vs. Alien

### NO HUMAN BEING IS ILLEGAL

- Using the term illegal vs undocumented
- No person can be **illegal**, only actions are illegal
- It is not a crime to be undocumented because civil violation is not illegal
  - As long as there is no criminal record

#### DACA

- Deferred Action for Childhood Arrivals
- The program has protected To apply for DACA, immigrants must meet certain requirements. They must have entered the U.S. before turning 16, have no serious criminal background and have lived continuously in the U.S. since June 15, 2007.
- In most states, you can get a driver's license
- Put utility bills in your name

# Important information about DACA requests:

Due to federal court orders, USCIS has resumed accepting requests to renew a grant of deferred action under DACA. USCIS is not accepting requests from individuals who have never before been granted deferred action under DACA. Until further notice, and unless otherwise provided in this guidance, the DACA policy will be operated on the terms in place before it was rescinded on Sept. 5, 2017. - Beginning Oct. 18, visitors from eight countries face new restrictions when trying to immigrate to the U.S. or get visitor visas.
